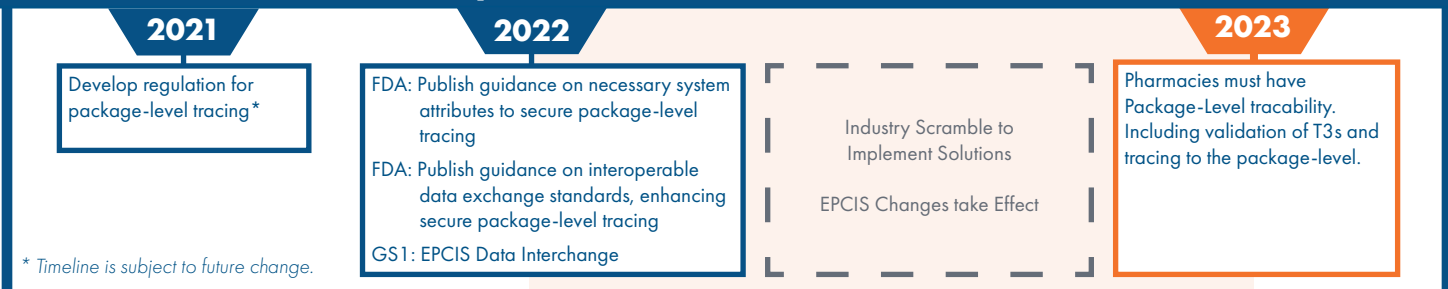


# Addressing DSCSA Compliance Requirements: 2020 and Beyond



## DSCSA Timeline of Events, per FDA Guidance\*



### 2020 DSCSA Dispenser Changes:

#### As of November 2020, dispensers must:

1. Only accept products that have FDA-specified, 2D Data-Matrix barcodes
2. Have system in place to capture and verify 2D-Barcode Data

*Note: 97% of Vendors are Compliant with the 2D Barcode Requirement. Products may also have linear-barcodes in addition to 2D Barcodes.*

### 2022 EPCIS Changes:

#### All GS1 and PDG Standards work necessary for EPCIS Implementation will be published in Q4 2022.

1. Receive EPCIS data prior to receiving product, followed by the verification of received product against EPCIS data.  
*Note: Roughly 1/3 of EPCIS Manufacturer to Wholesaler Connections are complete. EPCIS connections to Dispensers are just beginning.*
2. Must have the ability to respond to electronic audits
3. Electronically document and communicate salable returns (Sending EPCIS data)

## How to be Compliant with 2020 Requirements:

1. Update policies for drug shipment receiving to include:
  - Within the scope of DSCSA, verify received products have the required 2D-Barcode.
  - Within the scope of DSCSA, a process to REJECT products without the required 2D-Barcode.
2. Request that your wholesale distributors provide Lot Number and Expiration Date for all DSCSA transactions.
3. Work with 503B Compounding Facilities to ensure all products have 2D-Barcodes.

*Note: Although products from 503B compounders are exempt from DSCSA requirements, products that only have linear-barcodes might be misidentified as suspect.*

4. Recommended, not required: Implement or update existing barcode-scanning systems to:
  - Scan and interpret the new 2D-Barcodes.
  - Capture Lot Number and Expiration Date from the 2D-Barcode

*Note: Bedside Scanning Systems would benefit from Lot and Expiration data, although it is not a requirement. ConsortiEX Assure-Trak® Compounding Management System is 2D-Barcode Capable.*

## Preparing for 2023 DSCSA Requirements

Dispensers are encouraged have process in place to meet serialization and package-level tracing requirements.

Recommendations include:

1. Subscribing to "Verification Routing Services"
2. Expectations that each serialized package will need to be scanned and decommissioned after use.
