## Hospital Pack Capsules 100ct Product Information

### INSTRUCTIONS FOR USE – FOR ENTERAL OR ORAL USE ONLY

#### ORAL:

- Provide 1 capsule every 12 hours to patient within 24-48 hours of antibiotic use. Continue for duration of antibiotic regimen and for at least 10 days after. Alternatively, open capsule and mix entire contents into cool food or drink. Do not add to hot food or beverage.  
To alleviate occasional digestive upset, or as an adjunct for antibiotics, dispense two (2) capsules daily.\*

#### ENTERAL:

- Gather supplies for administration:
  - (1) Culturelle® Probiotic Supplement Capsule (check expiration date prior to administration)
  - (1) 20 mL luer tip syringe
  - (1) clean mixing container
  - 15 mL patient's feeding or cold/room temperature water
  - 1 pair clean non-sterile gloves
  - Germicidal wipes
- Establish a clean surface area away from patient's immediate bed space to prepare Culturelle® Probiotic in liquid form.
- Wash hands and place non-sterile gloves on clean hands.
- Open Culturelle® Probiotic by pulling apart the ends of the capsule and allowing entire powder contents to empty into clean mixing container.
- Place 15 mL of patient's feeding or cold/room temperature water into mixing container.
- Gently swirl powder and liquid to aid in disbursement of powder into the liquid.
- Place tip of 20 mL luer tip syringe into mixture.
- Draw up mixture into the syringe and remove excess air.
- Insert tip of enteral feeding syringe into feeding port and dispense mixture into feeding tube.
- Flush with water immediately.
- Dispose of syringe, mixing container, and packet per hospital policy.
